



Range Agreement & Release of Liability Form

I HEREBY ACKNOWLEDGE that I have voluntarily applied to participate in shooting and/or other activities sponsored by the Oak Tree Gun Club, LLC. / California Gun Girls, LLC, located at 23121 Coltrane Avenue, Newhall, CA 91321. I acknowledge that these shooting and/or other activities sponsored by the Oak Tree Gun Club, LLC / California Gun Girls, LLC are for the purpose of promoting shooting proficiency and fellowship among shooting clubs and groups including, but not limited to the NRA (National Rifle Association), NSCA, NNSA, ATA, TAT, SASS, IPSC, IDPA, together with the general public by providing practice ranges at which they can congregate and practice the respective disciplines, thereby increasing acceptance and membership in organized shooting. I ACKNOWLEDGE THAT SHOOTING ACTIVITIES NOT ONLY INCLUDE SHOOTING TIME, BUT ANY ACTIVITY WHATSOEVER THAT I ENGAGE IN WHILE AT THE OAK TREE GUN CLUB. THIS INCLUDES RESTING OR TRAVELLING BETWEEN SHOTGUN OR PISTOL RANGES, SHADE COVERS/PICNIC/PARKING AREAS, RETAIL FACILITIES AND RESTAURANT.

AS LAWFUL CONSIDERATION for having been permitted by Oak Tree Gun Club, LLC / California Gun Girls, LLC, or associated individuals, to participate in shooting and/or other activities including use of any of the facilities, I HEREBY AGREE THAT I, my heirs, distributees, guardians, legal representatives, and assigns WILL NOT SUE, make claim against, attach property of or prosecute Oak Tree Gun Club, LLC / California Gun Girls, LLC, and/or any sponsors, owners, partners, employees, or affiliated organizations for injury or damage resulting from negligence or other acts, whatsoever caused, by any owner, partner, employee, agent, or contractor of Oak Tree Gun Club, LLC / California Gun Girls, LLC. AS A RESULT OF MY PARTICIPATION IN SHOOTING ACTIVITIES OR ANY OTHER ACTIVITY WHILE ON THE PREMISES. In addition, I HEREBY DISCHARGE Oak Tree Gun Club, LLC / California Gun Girls, LLC and/or any sponsors, owners, partners, employees, or affiliated organizations from any and all claims or demands that I, my heirs, distributees, guardians, legal representatives, or assigns now have, or may have hereafter have FOR INJURY OR DAMAGE RESULTING FROM MY PARTICIPATION IN SHOOTING ACTIVITIES OR ANY OTHER ACTIVITIES AT THE OAK TREE GUN CLUB, LLC / CALIFORNIA GUN GIRLS, LLC.

I AM AWARE THAT ALL SHOOTING SPORTS AND RELATED ACTIVITIES ARE INHERENTLY HAZARDOUS ACTIVITIES. NEVERTHELESS, WITH KNOWLEDGE OF THE POTENTIAL RISKS INVOLVED, I HEREBY ACKNOWLEDGE AND AGREE THAT BY SHOOTING AT THE OAK TREE GUN CLUB, LLC / CALIFORNIA GUN GIRLS, LLC, RANGES, I AM VOLUNTARILY ACCEPTING ANY AND ALL RISKS OF INJURY OR DEATH.

I AGREE THAT I WILL WEAR EAR AND EYE PROTECTION AT ALL TIMES WHILE I AM PARTICIPATING IN ANY SHOOTING VENUE AT OAK TREE GUN CLUB, AND I WILL PERSONALLY ENSURE AND GUARANTEE THAT ANYONE WITH ME WILL ALSO WEAR EAR AND EYE PROTECTION, AND WILL HOLD OAK TREE GUN CLUB LLC / CALIFORNIA GUN GIRLS, LLC, HARMLESS FOR ANY INJURY THAT MAY RESULT FROM FAILURE TO ABIDE BY THIS RULE.

I AGREE TO TREAT ANY AND ALL GUNS ON THE PREMISE AS BEING LOADED, AND WILL NEVER POINT THE MUZZLE OF ANY GUN, AT ANY TIME, WHETHER LOADED OR NOT, AT MYSELF OR IN THE DIRECTION OF ANOTHER HUMAN BEING.

I WILL NOT DRAW A LOADED GUN FROM A HOLSTER OR FROM ANY OTHER LOCATION ON MY BODY, WHILE ENGAGED IN SHOOTING ACTIVITIES AT THE OAK TREE GUN CLUB.

I AM AWARE THAT AMMUNITION, BOTH FACTORY AND RELOADED, ARE SUBJECT TO DEFECTS. I RELEASE OAK TREE GUN CLUB, LLC & CALIFORNIA GUN GIRLS, LLC, FROM ANY RESPONSIBILITY FOR DAMAGE TO MY FIREARM, OR ANY INJURY OR DEATH RESULTING FROM THE USE OF DEFECTIVE AMMUNITION - PURCHASED AT OAK TREE GUN CLUB, LLC/CALIFORNIA GUN GIRLS, LLC. I AGREE THAT ALL LIABILITY FOR DEFECTIVE AMMUNITION IS THE RESPONSIBILITY OF THE MANUFACTURER/RELOADER.

I UNDERSTAND THAT FAILURE TO FOLLOW THE RULES AS THEY PERTAIN TO GUN AND RANGE SAFETY AND PERSONAL SAFETY, WILL RESULT IN REFUSAL OF SERVICE AND/OR BEING ASKED TO LEAVE THE FACILITY.

Safety Rules – Shotgun Ranges

Eye and Ear Protection is required for any person engaging in any activities (shooting or otherwise) on the range side of the chain link fence.

Only ONE (1) round of ammunition (shotgun shell) is to be loaded into any gun before any target is shot for "singles" shooting events.

Two (2) rounds may be loaded into a shotgun if a "doubles" event is being shot.

A MINIMUM OF 24" BARREL IS REQUIRED TO SHOOT ANY SHOTGUN VENUE AT OUR RANGE.

No one shall be permitted to move from station to station with a loaded gun.

NEVER turn away from the firing line (towards other stations or the parking lot/main building) with a loaded gun.

Muzzles are to be kept DOWN RANGE at all times.

Only shooters/pullers (scorekeepers) are permitted on the firing line. Spectators must wait on the benches provided behind the chain linked fence.

Only ONE (1) person may shoot at any single target at a time. (This does not include games such as "Annie Oakley" or "Buddy Back-Up" which should be cleared with the squad window beforehand.

No one under the age of 18 years is permitted to shoot any shotgun venue without being accompanied by an adult.

Absolutely no alcoholic beverages of any kind are allowed outside of the restaurant or on any of the shooting fields at any time. Anyone suspected of consuming alcoholic beverages prior to shooting will be asked to leave the premises.

No smoking while on any of the shooting fields. Please smoke only in the designated smoking areas.

Please review all Range Safety Rules posted at each station.

Please report any unsafe behavior to any Range Safety Officer or staff member immediately.
